1. Management and succession planning

The vast experience from some members are gradually transferred to the newer elected members. Further to the portfolios manned, was a decision taken that each position need to be shadowed by at least one other member on the Committee, to enable continuation. This decision came about after the setback experienced with health related issues of some committee members which impacted on the outputs and smooth running of our Branch. With this in mind, we still manage to serve our wider Branch members by continuous communication and service by having been able to present 9 matches since January 2025, 429 players participated, 20 members participated in the Nationals at Bloemfontein and we are again 20 members strong in the Regional field. There are a further 8 games scheduled for the remainder of this year

Members are willing to support the committee, but are reluctant to avail themselves to serve as committee members.

2. Administration (Including branch meetings, newsletters)

Meetings are held monthly one week before the monthly game to ensure smooth organising of the day. Matters related to the previous as well as upcoming events are discussed. This also serves as the platform to discuss any issues to be captured in the Monthly Newsletter which are circulated shortly after the meeting.

3. **Member management**

The Members' database is updated monthly with new and leaving members and we further have an updated database linked to the main one indicating the members' playing statistics for the year. This is use in support when having to determine the participants for National and Regional events.

Due to the wide and long distances our members have to travel to play the monthly games, we try to be as accommodative as possible to promote participation by keeping costs as low as possible with the support of our various clubs. This in itself is continuously becoming more and more challenging. From our current members, there are also a third who are not actively playing in our monthly games, but we continuously invite and encourage members to participate.
